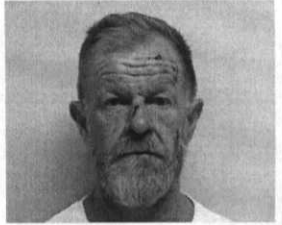

**Probable Cause for Arrest with out Warrant:**

While patrolling American Fork Canyon I was flagged down by several citizens (witnesses) claiming they needed my help for a lady who had been involved in a possible domestic issue. According to the citizens they had witnessed a male and a female involved in a physical altercation wherein the male involved was hitting the female and pulling her out of the white truck they both were riding in. According to witnesses the male individual was pulling at the female attempting to remove her from the vehicle; in doing so the male pulled the shorts and under garments from on the female, throwing them out of the truck on to the road, then grabbing the female, removing her from the truck and driving off.

After speaking with witnesses I spoke with the female involved, identifying her as [REDACTED] [REDACTED] stated that earlier in the day she and her husband Dwane Youd, DOB: [REDACTED] had been verballing argueing abouty an affair [REDACTED] had been having with another man. According to [REDACTED] she had told Dwane last night, that she was still seeing the same man whom she had had an affair with last year, and that the affair been on-going since that time. [REDACTED] said she and Dwane began drinking this morning and had been arguing about the affair. That at some point in the afternoon Dwane had suggested the two of them take a drive up American Fork Canyon to Cascade Springs where they could take a walk and talk. While there, according to [REDACTED] Dwane became increasingly aggitated about the affair, to the point he began screaming and yelling at her as they walked back to the truck, getting in and driving away.

[REDACTED] continued to explain that as they drove down the canyon Dwane began yelling at her to get out of the truck. At one point Dwane stopped the truck, physically removing [REDACTED] from the truck, attempting to leave her on the side of the road. [REDACTED] said as Dwane got back in the truck to drive away, she got into the back of the truck; she just wanted to go home. As Dwane drove down the canyon with [REDACTED] in the back of the truck, weaving back and forth and slamming on the breaks causing [REDACTED] to physically slam around in the back of the truck.

[REDACTED] explained that after a sort while Dwane stopped the truck really fast and got out of the cab of the truck grabbing at her in the back of the truck trying to get her out of the truck again. [REDACTED] said she climbed back into the cab of the truck in an attempt to get her purse and her dog, when Dwane grabbed her from behind pulling at her and yelling for her to get out of the truck. As Dwane continued to pull at [REDACTED] waste, he pulled her shorts and underwear from her body and threw them from the vehicle, then grabbing [REDACTED] again as he punched her in the lower back and buttocks trying to remove her. According to [REDACTED] at one point she was able to turn around to where she was facing Dwane as he was pulling at her at the waste and legs. [REDACTED] said it was once she was facing Dwane that he began slamming his forehead into her face several times, until she reached up to his face and began scratching and clawing at Dwane's face, hoping he would stop hitting her in the face with his head. Eventually Dwane did remove [REDACTED] from the truck, naked from the waste down, then returned to the cab of the truck, grabbing her 4 month old puppy and throwing it from the truck as well. [REDACTED] stated that at this point several people came to her aid in assisting her to get her clothes back, and protecting her from further attack from Dwane.
