The undersigned Detective S. Warenski - Unified Police Department, Agency Case No. 20-94102, upon a written declaration states on information and belief that the defendant, JONATHAN CROCKER, committed the crime(s) of:

COUNT 1

ASSAULT, 76-5-102 UCA, a Class B Misdemeanor, as follows: That on or about August 10, 2020 at 3025 East 3300 South in Salt Lake County, State of Utah, the defendant did (a) attempt, with unlawful force or violence, to do bodily injury to another; or (b) commit an act, with unlawful force or violence, that caused bodily injury to another or created a substantial risk of bodily injury to another.

THIS INFORMATION IS BASED ON EVIDENCE OBTAINED FROM THE FOLLOWING WITNESSES:

Juan Solaresmejia, Detective S. Warenski, and John Thieling.

DECLARATION OF PROBABLE CAUSE:

Your declarant bases this Information on the following:

The statement of John Thieling that on August 10, 2020, he was in the Café Rio located at 2025 East 300 South in Salt Lake County. A man, later identified as JONATHAN CROCKER, parked his car and left his driver side door open. CROCKER came into the restaurant to pick up his food and he was not wearing a face covering. Mr. Thieling heard a Café Rio employee tell CROCKER that his food was not ready, and that CROCKER needed to wait in his car because he was not wearing a face covering. CROCKER would not step back or leave the restaurant, so Mr. Thieling approached him and asked him to step back and to go out and close his car door. CROCKER told Mr. Thieling to mind his own business and punched Mr. Thieling in the face.

The statement of Officer Juan Solaresmejia that he responded to the Café Rio to investigate the assault. Officer Solaresmejia noticed that Mr. Thieling had blood in his mouth. Mr. Thieling showed him a cut inside his mouth on his left cheek.

CROCKER later called dispatch and requested that an officer call him. Officer Solaresmejia meet with CROCKER at CROCKER's father's home. CROCKER denied punching Mr. Thieling and said that Mr. Thieling was harassing him for not having a face covering.

Pursuant to Utah Code Annotated § 78B-18a-106 (2018) I declare under criminal penalty under the law of Utah that the foregoing is true and correct.
